

NASA Flight Jacket Sweepstakes Official Rules

NO PURCHASE OF GOODS OR SERVICES, PAYMENT OF ANY MONEY OR SUBMISSION TO ANY SALES PROMOTION IS NECESSARY TO BE ELIGIBLE TO PARTICIPATE, AND NONE OF THE ABOVE WILL INCREASE THE ODDS OF WINNING. HAVING A NASA FEDERAL CREDIT UNION MEMBERSHIP WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Sweepstakes Sponsor:** NASA Federal Credit Union, Upper Marlboro, Maryland
- 2. Eligibility:** Open to residents of the 50 U.S. states and the District of Columbia (DC) who are 18+ and attendees of the SpaceCom Conference between January 28-30, 2026. NASA Federal Credit Union employees, volunteers, and their immediate families, including household members, are not eligible to win. Any member who has now or in the past defaulted under a NASA Federal Credit Union agreement or otherwise caused a loss to the Credit Union is also ineligible.
- 3. To enter without purchase:** Print your full name, complete billing address, day and evening phone numbers (including area code), email address (if any), date of birth, AND the last four (4) digits of your Card on a 3" x 5" piece of paper and mail it, with proper postage to: NASA Flight Jacket Sweepstakes Request, c/o NASA FCU, Attn. Marketing, 500 Prince Georges Blvd. Upper Marlboro, MD 20774. Mail-in entries must be postmarked and (received) by January 30, 2026. Entry periods are January 28-30, 2026.
- 4. Prizes:** There are three prizes. Three flight jacket winners will be selected from the cumulative entries collected in the SpaceCom Conference period. Prize drawings are conducted at the end of the conference and mailed to the address provided. All prizes will be awarded. Approximate retail value of each flight jacket is \$225.
- 5. Winner Selection:** The sweepstakes winners will be randomly selected from all eligible entries received/ postmarked according to the schedule presented in Section 3 "To Enter". The prize drawings will be conducted by NASA Federal Credit Union, whose decision is final, at the end of the SpaceCom Conference. No prizes awarded after February 6, 2026. Odds of winning depend on the total number of eligible entries received by the end of the conference. Limit one prize per winner, winner's household, and winner's immediate family. Federal, state, and local taxes are the sole responsibility of the prizewinner.
- 6. To Claim Prize:** The three winners will be notified via e-mail within 7 days after drawing date. If prizewinner does not accept the prize, another random drawing will be held from the remaining eligible entries and the prize will be awarded to the winner of that drawing.
- 7. General Terms:** Valid only in the United States. All federal, state, and local laws and regulations apply. Sweepstakes void where prohibited by law. Members and Sweepstakes entrants agree to abide by the terms of these Official Rules, which will be posted on the NASA Federal Credit Union website throughout the Sweepstakes and by the decisions of NASA Federal Credit Union which are final and binding on all matters pertaining to this Sweepstakes. Acceptance of a prize constitutes permission for NASA Federal Credit Union to use the winner's name and likeness online and in print, or any other media, in connection with the Sweepstakes without additional compensation
