

NASA Flight Jacket Sweepstakes 2025 Official Rules

NO PURCHASE OF GOODS OR SERVICES, PAYMENT OF ANY MONEY OR SUBMISSION TO ANY SALES PROMOTION IS NECESSARY TO BE ELIGIBLE TO PARTICIPATE, AND NONE OF THE ABOVE WILL INCREASE THE ODDS OF WINNING. HAVING A NASA FEDERAL CREDIT UNION MEMBERSHIP WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Sweepstakes Sponsor:** NASA Federal Credit Union, Upper Marlboro, Maryland
- 2. Eligibility:** Open to residents of the 50 U.S. states and the District of Columbia (DC) who are 18+ and attendees of the SSAI Benefits Fair on October 16, 2025. NASA Federal Credit Union employees, volunteers, and their immediate families, including household members, are not eligible to win. Any member who has now or in the past defaulted under a NASA Federal Credit Union agreement or otherwise caused a loss to the Credit Union is also ineligible.
- 3. To enter:** Complete the entry form at www.nasafcu.com/nasa-jacket. You may also enter alternatively by doing the following: Print your full name, complete billing address, day and evening phone numbers (including area code), email address (if any), and date of birth on a 3" x 5" piece of paper and provide it to the representative at the NASA Federal booth. Entry period is on October 16, 2025, and entries must be received by October 16, 2025.
- 4. Prizes:** There is one prize. One flight jacket winner will be selected from the cumulative entries collected during the Benefits Fair. Prize drawings are conducted at the end of the Benefits Fair and mailed to the address provided. All prizes will be awarded. Approximate retail value of each flight jacket is \$225.
- 5. Winner Selection:** The sweepstakes winner will be randomly selected from all eligible entries received/postmarked according to the schedule presented in Section 3 "To Enter". The prize drawings will be conducted by NASA Federal Credit Union, whose decision is final, at the end of the Benefits Fair. No prizes awarded after October 16, 2025. Odds of winning depend on the total number of eligible entries received by the end of the Benefits Fair. Limit one prize per winner, winner's household, and winner's immediate family. Federal, state, and local taxes are the sole responsibility of the prizewinner.
- 6. To Claim Prize:** The winner will be notified via e-mail within 7 days after drawing date. If prizewinner does not accept the prize, another random drawing will be held from the remaining eligible entries and the prize will be awarded to the winner of that drawing.
