

Instructions to Return Your Completed Application

- 1. Identification* (ID): Please include a copy of government-issued identification for each owner. Copies must be notarized and include clear picture AND information. Ex. State Issued Driver's license/ID card, or Passport. Existing account owners may log in to Online or Mobile Banking to provide identification via NASA Federal's secure message.
- 2. Mail Application: NASA Federal Credit Union, P.O. Box 1588, Bowie, MD 20717-1588. Or, NASA Federal Credit Union, 500 Prince Georges Blvd, Upper Marlboro, MD 20774.
- *When legal name is not reflected on ID, supporting documentation is needed: Marriage License or Court Document reflecting name change. If current address is not reflected on ID, supporting documentation is needed: utility bill, lease agreement, or motor vehicle address change document.

To reopen account, members must mail application and include a check for at least par value.
